HEALTHCARE HEROES AT WORK

Colquitt Regional's mission is to provide exceptional health care that exceeds expectations. Although that mission has never wavered throughout its history, it took on a new meaning in March 2020, as the world began to experience a new normal.

As COVID-19 made its way into South Georgia, Colquitt Regional's administration created a designated task force to face the pandemic head-on. This team, which met daily for months, was assembled to implement various safety protocols and procedures to ensure that patient safety remained the top priority. During the pandemic, the hospital faced numerous trials and challenges - cancelling elective surgeries for a period of time, shifting responsibilities and roles of employees, limiting and eliminating visitations policies, and, ultimately losing patients and loved ones to this unyielding virus.

For those on the frontlines of patient care, the past year has been long and, at times, defeating. Nurses and providers have had to adjust to wearing personal protective equipment (PPE) in patient care settings, for hours on end. They have held the hands of patients they knew would never make it home to their families. They have seen firsthand the path of destruction that COVID-19 has left on families and friends. Although there have been challenging times, there have also been

moments of joy and healing. In April 2020, the hospital celebrated with the first patient who had been taken off the ventilator and discharged home after 72 days in the hospital. In May 2020, a 22-year-old patient, whose entire family had COVID-19 at the same time, was also discharged after being in the hospital for 69 days. These are the moments that have made the difficult days more bearable.

Not only have the employees rallied together to take care of each other, but the community has supported the hospital every step of the way. Meals have been donated, masks have been sewn, cards have been sent, and prayers have been lifted for employees and patients. Each person within the organization has felt the hands of the community holding Colquitt Regional during the pandemic.

Over the course of the year, Colquitt Regional has seen the worst, and it has also experienced the best. The healthcare heroes within the organization have made the difference during the pandemic with their tenacity and unwavering commitment to compassionate care and to being the healthcare provider that patients trust in every medical situation.

VACCINES

Since the first case of COVID-19 was identified, the federal government and U.S. private sector have worked together under Operation Warp Speed – an initiative to accelerate the testing, supply, development, and distribution of safe and effective vaccines, therapeutics, and diagnostics to counter the virus by January 2021.

Since January of 2020, significant strides have been made toward the treatment and containment of COVID-19 cases. Testing has become widespread, both rapid and standard, and the hospital is now able to help COVID-19 patients by offering a larger variety of treatment options that have been shown to improve patient outcomes.

However, one of the most momentous moments in the fight against COVID-19 has been FDA approval of two vaccines. The Moderna and Pfizer vaccines received emergency use authorization in December 2020 and quickly began to make its way into healthcare systems across the United States. Colquitt Regional received its first shipment of vaccines on December 17, 2020.



History was made on that day as Dr. Michael Thayer, an emergency department physician who has been on the front line providing care to COVID-19 patients, was the first hospital employee to receive the vaccine. In the days following the administration of the first vaccine at the hospital, Colquitt Regional's COVID-19 task force met to discuss and plan for future vaccination efforts.



TNCPE 2020 COMMITMENT AWARD

Colquitt Regional received notification in late 2020 that it will receive the Tennessee Center for Performance Excellence (TNCPE) 2020 Commitment Award. This award recognizes organizations who demonstrate serious commitment and implementation of performance improvement principles outlined in the Baldrige Framework for Excellence.

"The journey to this award started three years ago and we are proud to be one of only six organizations nationwide to receive this status in 2020," said Colquitt Regional President and CEO Jim Matney. "We are committed to being exceptional in every aspect – patient care, safety, workplace satisfaction, and everything in-between. This award further confirms that, even during a global pandemic, we are still dedicated to bringing the best to our patients and community."

The Baldrige Framework is implemented across industries of all sorts to help empower organizations to reach goals and improve results, along with becoming more competitive by aligning its plans, processes, decisions, people, actions, and results.

"Over the past three years, our leadership team has intensely analyzed the hospital's strategic plan and organizational structure," said Hospital Authority Chairman Maureen A. Yearta, Ed.D. "In doing so, we are ensuring that the hospital is focused not only on delivering high quality healthcare today, but we are also operating in a manner that ensures the long-term stability and growth of healthcare services in our region."

Organizations that choose to apply for this prestigious award create a self-assessment that is analyzed by a team of TNCPE examiners. The self-assessment is based on three key factors including the Criteria for Performance Excellence, a set of interrelated core values and concepts, and a scoring system that is utilized to gauge the organization's maturity.

The Criteria for Performance Excellence is made up of a set of questions about seven critical aspects of managing and performing as an organization: leadership strategy, customers, workforce, operations, results, and measurement, analysis and knowledge management.

After analyzing the self-assessment, the examiners make a site visit to gain a thorough understanding of the organization and the team provides a detailed feedback report that identifies strengths and opportunities for improvement. A TNCPE panel of judges then determines which award level the organization will receive.

The 2020 TNCPE Commitment Award will be accepted by Colquitt Regional Medical Center on March 25, 2021, as part of the virtual 2020 TNCPE Excellence Conference.





EXPANDING CANCER CARE

COLQUITT REGIONAL BRINGING RADIATION ONCOLOGY SERVICES TO MOULTRIE

In 2020, Colquitt Regional unveiled plans to begin offering radiation oncology to patients. This new service line will allow the Edwards Cancer Center to take a more comprehensive approach to cancer treatment, in addition to the current offering of chemotherapy and immunotherapies.

Construction on the new center began in the middle of May and will be an expansion of the east side of the hospital in what presently serves as a parking area.

The new \$7.7 million, 6,900 sq. ft. building will include a lobby, conference area for patient consultation, six exam rooms, four dressing rooms, and a treatment area.

The treatment area will house the Elekta Versa HD™ radiation treatment system. The Versa HD provides the flexibility to treat a broad spectrum of tumors throughout the body, while enabling treatment of highly complex cancers that require extreme targeting precision. The system's patented technology conforms to each patient's tumor size, shape and volume, allowing physicians to administer higher dose rates that can enhance treatment effectiveness while protecting critical anatomy such as the heart, spine, or bladder.

Each dosage of radiation is determined by a dosimetrist, who will use scans of the patient to tailor their dosage to their exact needs. The machine then creates a beam that is focalized on the tumor, working to make small breaks in the DNA inside cells. The breaks that the radiation therapy creates keeps cancer cells from growing and dividing and causes them to die.

A typical treatment takes only two to five minutes and patients can count on receiving this therapy during a three-to-six-week period, depending on the patient's needs.

"We have been working toward establishing a radiation oncology center for several years," said Colquitt Regional President and CEO Jim Matney. "It was important to us to provide access to this service for the people of Moultrie and the surrounding areas. The technology that we will offer is the most modern available on the market."

The Versa HD will allow faster treatment times which can improve patient comfort, particularly for older patients who may find it difficult to remain in one position over

extended periods of time. It will also minimize potential damage to surrounding tissue of the affected area and decrease the total number of needed treatments for patients.

One of the greatest benefits of this new facility and state-of-the-art technology is that it will not require patients who live in Colquitt County to travel out of the county to receive treatment. Currently, any patient that needs radiation treatment must travel a minimum of 30 minutes to receive care.

In addition to Edwards Cancer Center providers Dr. Wenhui Zhu and Kerri Holloway-Cox, FNP-C, Dr. Steve Johnson and Dr. David Saunders will be providing care for radiation patients. Johnson and Saunders, who are both on staff at Archbold Memorial Hospital, will serve as the primary radiation oncologists.

"We are very strategic in our planning for services that we want to add to our current lineup," said Hospital Authority Chairman Maureen A. Yearta, Ed.D. "Forty to 60 percent of cancer cases require radiation as part of their treatment meaning this service is needed in our community. By providing this service locally, it will ease the discomfort of many cancer patients and reduce stress upon family and friends who would otherwise have to drive some distance to take their loved ones to radiation treatment."

The new radiation oncology unit is on track to open March 2021.





GEORGIA'S *NEWEST* PATHWAY HOSPITAL

The Pathway designation is a global credential that highlights Colquitt Regional's commitment to creating a healthy work environment where nurses feel empowered and valued.

"It is an honor to be one of the five hospitals in the state of Georgia and the only organization in South Georgia to receive this designation," said Colquitt Regional President and CEO Jim Matney. "Our Pathway team and nurses have worked diligently towards this accreditation and we are proud for them to be recognized for their efforts."

Colquitt Regional's nurses are an integral part of the healthcare team, with a voice in policy and practice. Pathway nurses are engaged, resulting in higher job satisfaction, reduced turnover, improved safety, and better patient outcomes.

Colquitt Regional began the journey to Pathway to Excellence designation in 2015 and initiated a yearlong application process in 2019.

There are several qualifications that are necessary to be designated as a Pathway organization. The hospital must meet six practice standards

that are essential to an ideal nursing practice environment. This includes shared decision-making, leadership, safety, quality, culture of well-being, and professional development.

A 300-page document was submitted to ANCC exemplifying the ways in which Colquitt Regional Medical center meets these standards. After the approval of the submitted document, ANCC surveyed 351 of our LPN, RN, and Advanced Practice Nurses to validate the information submitted in the document.

"We are thrilled that Colquitt Regional has achieved Pathway designation status," said Vice President of Patient Services and CNO Dena Zinker, MSN, RN, NE-BC, FACHE. "To receive this designation in the middle of a global pandemic is a testament to the culture we have built here at Colquitt Regional and the dedication and resiliency of our nurses. They never cease to amaze me with the work they carry out on a daily basis."

As a Pathway organization, Colquitt Regional leads the effort to enhance quality of care, patient and nursing safety, and the future of healthcare delivery.



KIDNEY STONES

Colquitt Regional acquired a new technology to its Urology service line in 2020 that will be vital to patients who suffer from kidney stones.

The Dornier Delta III Lithotripter has been instrumental in non-invasively relieving kidney stones in patients all over the world by utilizing Extracorporeal Shock Wave Lithotripsy (ESWL).

The Delta III features a 120-degree therapy head that allows for increased range of access that makes it easier to target any stone. It also includes a unified hand control that allows physicians to manipulate the movement of the lithotripter at the touch of a button.

Patients who undergo this 60-minute procedure are placed under general anesthesia and the therapy head is positioned over the kidney region, all while maintaining patient comfort. The physician then triggers the electromagnetic shock waves that pass through the body to help break down the kidney stones.

While this procedure is not new to Colquitt Regional, acquiring this innovative and improved device will provide greater access for patients needing care, allowing for lithotripsy services to be available to patients seven days a week.

"By adding the Dornier Delta III to our lineup, we are ensuring that our patients and community members have access to the latest healthcare technology," said Jim Matney, Colquitt Regional president and CEO. "Kidney stones can be incredibly painful and this new equipment will provide needed relief to patients quickly."

Implementing this new technology at Colquitt Regional will also provide improved imaging quality

with 400% more power and two imaging modalities (Ultrasound or X-Ray).

The Optical Coupling Control, an integrated camera in the therapy head, increases visualization of the kidney stones that allows physicians to identify and treat more stones in more patients with increased effectiveness.

Dr. Emerson E. Harrison, new urologist at Sterling Center Urology and Urogynecology, played a vital role in bringing this technology to Colquitt Regional.

"According to the National Kidney Foundation, more than half a million people go to the emergency room for kidney stone problems each year," said Harrison. "Having this cutting-edge lithotripter on hand will allow us to serve our patients with advanced care and increased efficiency."

Harrison, a North Carolina native, received his medical degree from the Brody School of Medicine at East Carolina University in Greenville, North Carolina. He then went on to complete his surgical internship, residency, and urologic surgery residency at Emory University.

He comes to Moultrie with over 35 years of experience in urologic surgery and most recently practiced in the Atlanta area. Practicing alongside Harrison is Anthony Davis, PA-C, who began with Sterling Physician Group in the summer of 2019.

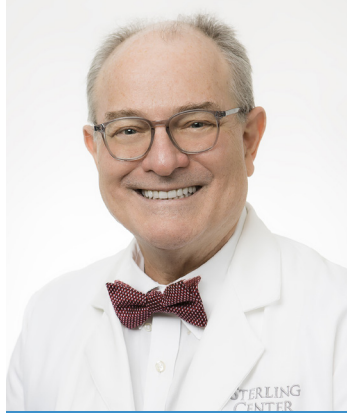

During a year filled with challenges, and despite not being able to volunteer in the hospital from March to July, the Bluebirds were still working to give back to this organization. During 2020, they donated a total of \$18,778 to the hospital. These funds aided in the pandemic relief fund, children's fund, purchasing a charging station in the OB lobby, donating digital thermometers to the Edwards Cancer Center and buying games, cards, and bed-side activities for our swing bed unit. In addition, they also provided snacks during the pandemic, weekly newspapers to patients, and held their annual toy drive in July.

Georgia HEART Tax Credit Program

Last year, Colquitt Regional Medical Center was fortunate enough to receive over **\$3.9 million** through the Georgia Rural Hospital Tax Credit program. Over 260 Georgia taxpayers deferred their 2020 state income tax obligation to support our hospital in exchange for a 100% state income tax credit on their state tax return.

These tax credit contributions helped complete the expansion and construction of a new premier radiation oncology facility at the Edwards Cancer Center. It also helped provide treatments for our cancer patients with financial need.

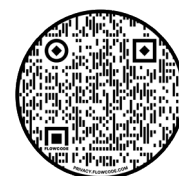

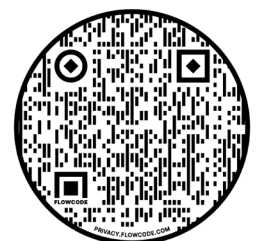
