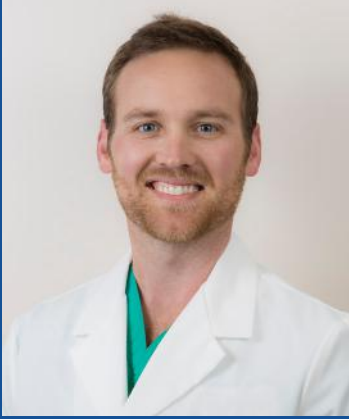

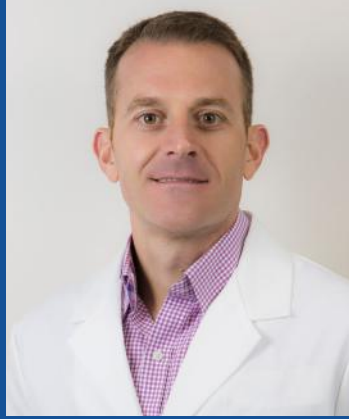

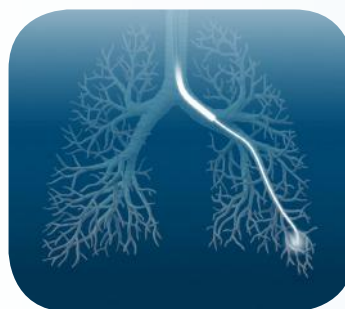

SAVING LIVES WITH CUTTING-EDGE TECHNOLOGY!

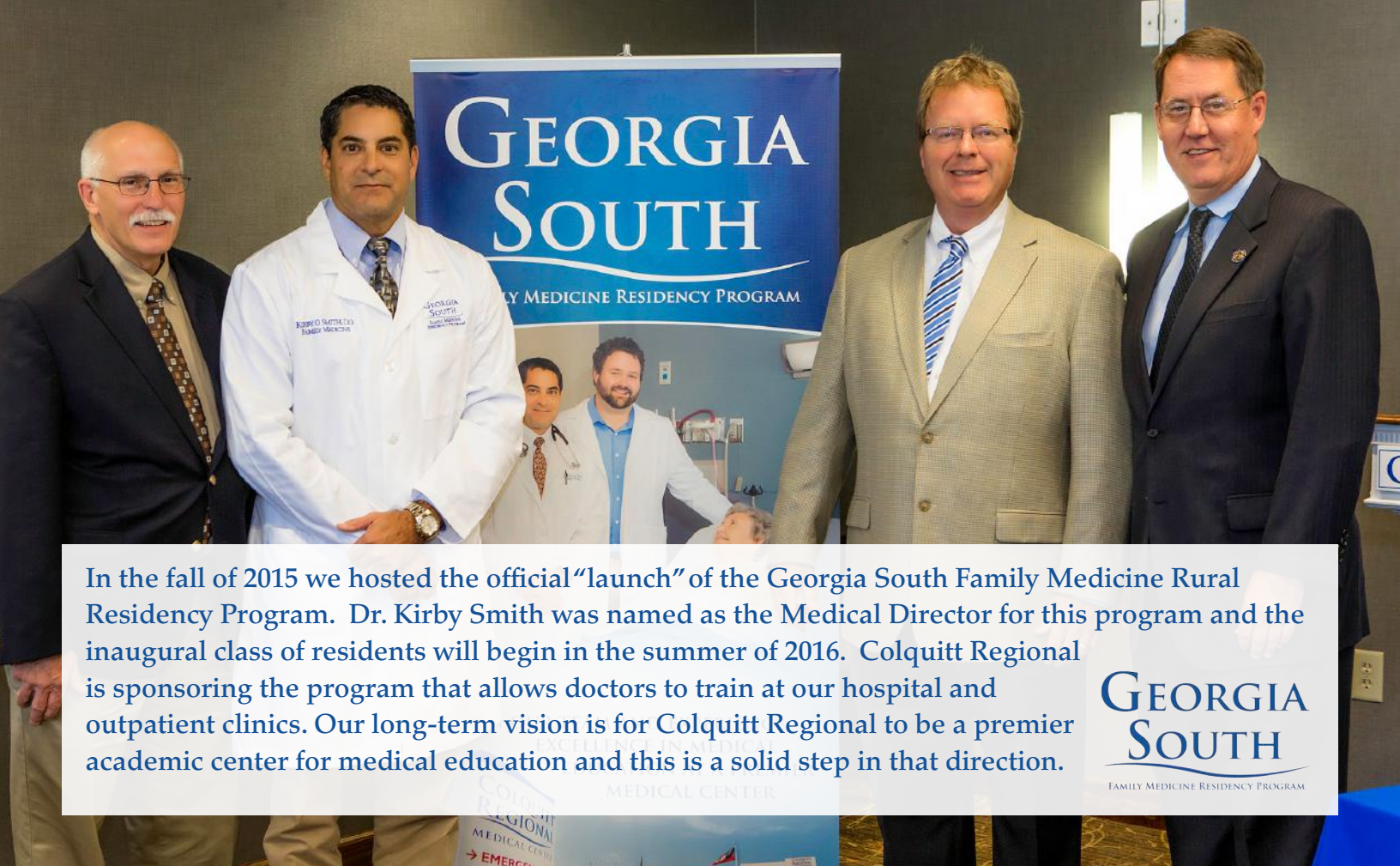

THE PROCEDURE KNOWN AS A NAVIGATIONAL BROCHOSCOPY ALLOWS PHYSICIANS TO NAVIGATE AND ACCESS DIFFICULT-TO-REACH AREAS OF THE LUNG FROM THE INSIDE. MANY PATIENTS ARE ABLE TO AVOID UNNECESSARY SURGICAL PROCEDURES FOR NON-MALIGNANT LUNG NODULES OR HAVE AN EARLIER DIAGNOSIS OF LUNG CANCER. THIS STATE-OF-THE-ART EQUIPMENT IS INCREASING THE LIKELIHOOD OF POSITIVE HEALTH OUTCOMES FOR OUR PATIENTS.

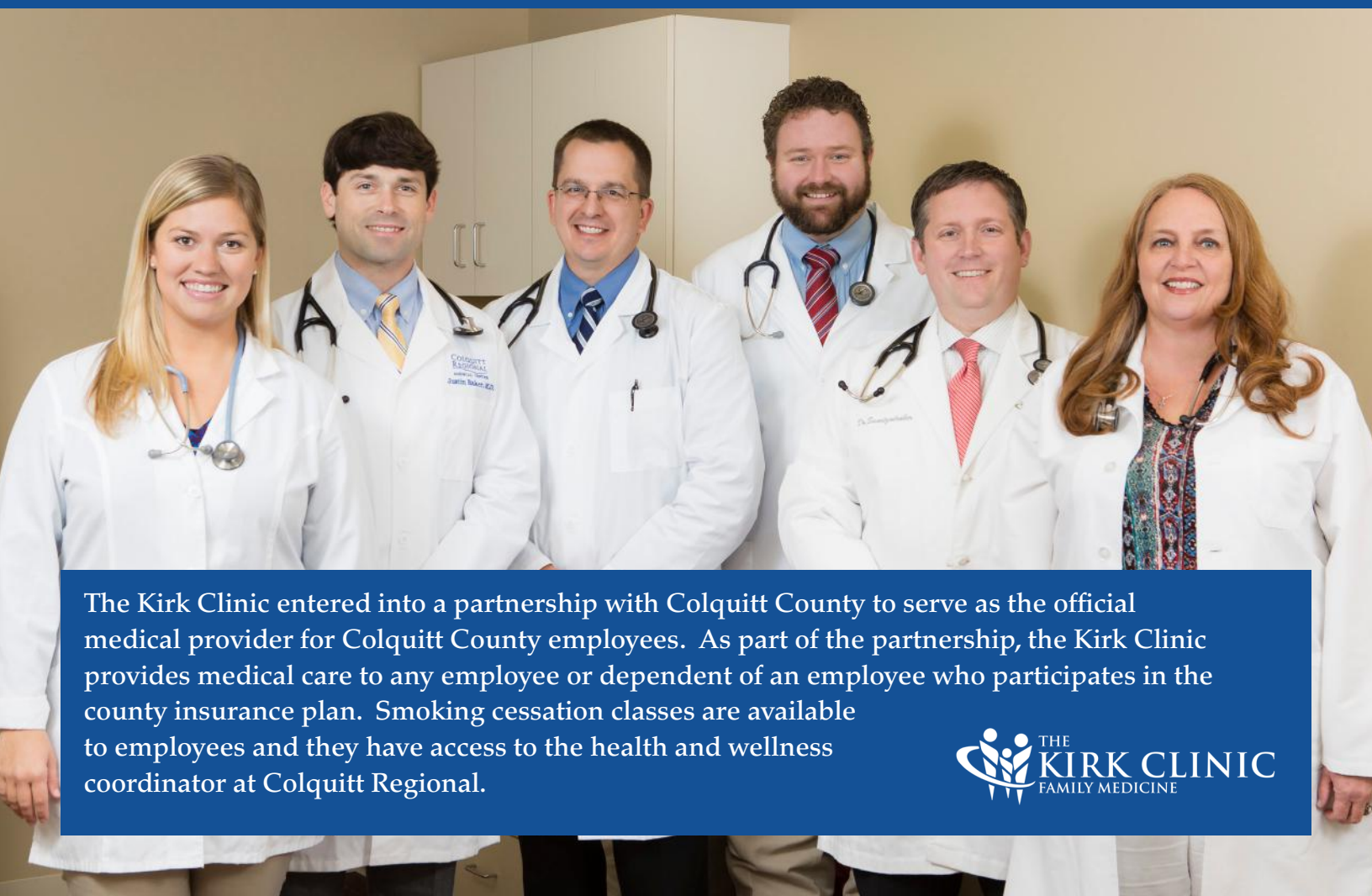

In the fall of 2015 we hosted the official “launch” of the Georgia South Family Medicine Rural Residency Program. 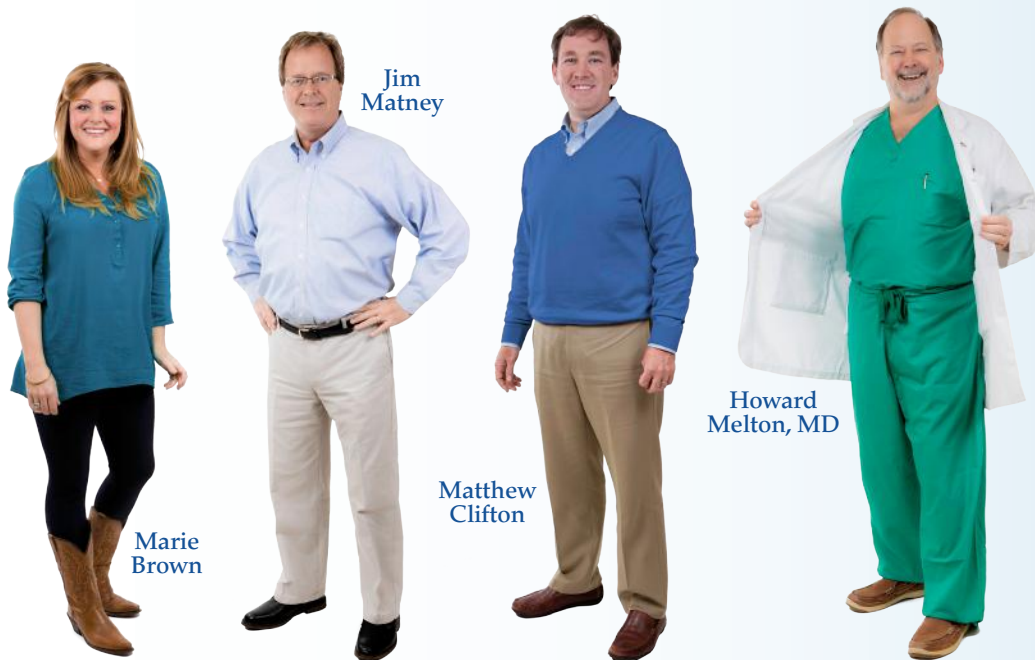
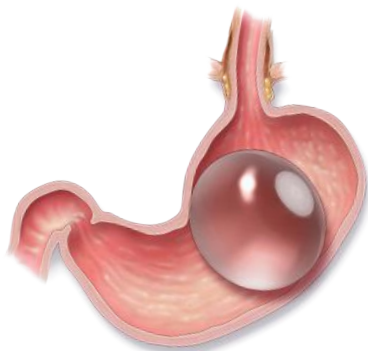
VEREEN REHABILITATION

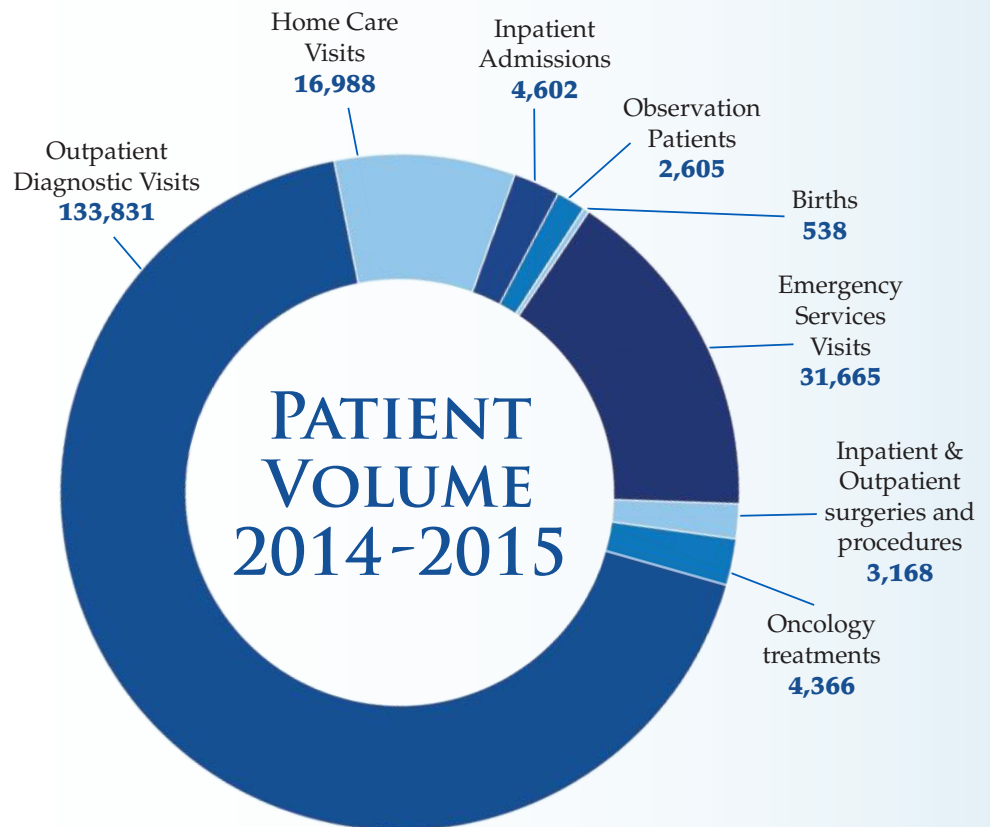

CELEBRATE!

2015 was our year to celebrate our successes with the Capital Campaign completed in 2015 to assist the hospital in a \$30 million expansion and renovation project. Individuals and business partners rallied this healthcare improvement and made donations and pledges totaling \$2.3 million!

Our calendar year in review:

- Gifts received in 2015 totaled \$716,325. \$83,478 of that was from five fundraisers conducted throughout the year.
- Over 570 employees invested their charitable giving to our foundation and contributed \$93,771.
- We recognized 42 new donors joining our Founder's Society, a lifetime recognition designation for those who have given \$10,000 or more. In addition, we honored 60 business partners at a celebratory event.
- In 2015, we revamped our wheel chair ramp building program by partnering with the First Baptist Church in Moultrie. Nineteen ramps were built throughout the year.
- The Lowry Scholarship Fund was established to provide future scholarships to assist non-physician employees in their career advancement.
