2018 HIGHLIGHTS

TECHNOLOGY: SAVI SCOUT

SAVI SCOUT, a new radar-based technology, was developed to make the surgical process easier and more comfortable for women, while helping surgeons remove problematic cells and spare as much breast tissue as possible. Colquitt Regional is the first hospital in the region to implement this system, which will help to reduce the cost of care, while providing better outcomes for healthcare providers and their patients.

8TH & 9TH "A" HEALTH RATING



Colquitt Regional earned its 8th and 9th consecutive "A" health ratings from The Leapfrog Group in 2018. Colquitt Regional was one of 15 hospitals in Georgia awarded an "A" for its efforts in protecting patients from harm and meeting the highest safety standards in the U.S. Much like a report card, the Safety Grade assigns grades to hospitals across the country based on their performance in preventing medical errors, infections and other harms among patients in their care.

During 2018, Colquitt Regional continued to expand services and improve patient experience within the hospital. After identifying the need for a new place to house the Oncology department, the vision for the Edwards Cancer Center came to life through the help of numerous volunteers, employees and community members.

To raise the funds needed for the new facility, a capital campaign was launched in 2016 with a goal of raising \$1.3 million by the end of 2017. To kick-start the campaign, the Colquitt Regional Medical Foundation received a signature donation from the Edwards family. The Edwards Cancer Center is named in honor of Bill Edwards who lost his battle with cancer in August 2015.





Helping Enhance Access to Rural Treatment

Colquitt Regional partnered with Georgia HEART Hospital Program to become eligible for participation in the Georgia Rural Hospital Tax Credit program. In 2018, over 200 donors exchanged their state income tax expense for a tax credit. Our hospital received over \$2.3 million in contributions. These funds helped complete the Edwards Cancer Center and provided aid to chemotherapy patients.
